Will the routing number change with the merger?

We're happy to share that our routing number will remain the same.

I have my Social Security check automatically deposited with Ent. Do I need to do anything as soon as the merger happens?

The good news is you don't need to do anything right away. If there are any changes in the future, they'll be communicated clearly and well in advance. But for now, you don't need to take any action.

Do I need to get new checks right away?

You're good to keep using your Ent checks and reordering as needed. If anything changes later with check ordering, we'll give you plenty of notice.

What will the new credit union be called?

Our name will be Wings Credit Union, which celebrates both credit unions' aviation legacies. The concepts of wings and flight also reflect the ideas of upward movement, goals, aspirations and achievement.
